Deposits are NON REFUNDABLE. Cancellations must be done via certified letter to FOUR SEASONS LIMO 14 days prior to your rental. If you want to cancel your contract, and there are less than 14 Days until your rental, you will be responsible to pay the total contract price which will be charged to the credit card on file. If there are more than 14 days until your rental you can cancel and pay only the 30% non-refundable deposit. The day you reserve the limo does not matter, meaning if you book the limo with only 13 days until your event there are no cancellations without being billed the total contract price. All deposits are non-refundable. FOUR SEASONS LIMO may at its discretion offer a credit for use at another time.

YOU MUST INCLUDE COPY OF CREDIT CARD

1. No one under age 21 is permitted to consume alcohol. Violation will result in early termination of service-no refunds. 2. No smoking in the vehicles. Violation will result in a \$100 fine per incident. No exceptions. 3. There will be a \$150 cleaning surcharge for vomit incidents. 4. All tolls and parking fees are in addition to the contract price and must be paid separately. 5. There will be a \$10 charge per broken or missing glasses. 6. There will be a \$100 surcharge for excessive cleaning at the discretion of the company. 7. Persons who are unruly or disruptive or conduct illegal activities will be removed from the vehicles at the discretion of the driver and no refunds will be issued. 8. We are not responsible for lost, damaged, or stolen property. 9. No illegal drug usage. Violation will result in early termination with no refunds. 10. Overtime will be billed in 1 hour increments. By agreeing to service with FOUR SEASONS LIMO the customer is agreeing to pay for overtime accrued. Hourly rate is determined by the total contract price divided by the number of guaranteed hours. 11. Customer agrees that replacement Limousine may be substituted in the event of any major mechanical issues, limo involved in an accident, etc. 12. All entertainment including but not limited to CDs, DVDs, VHS tapes and more is to be provided by the client. No guarantee on the color of the limousine though we do our best to accommodate requests. Due to the nature of our business, we do not guarantee all TV's, lighting, and equipment will operate at the time of rental. In order to meet your guaranteed service request FOUR SEASONS LIMO may use subcontractors to complete your service. FOUR SEASONS LIMO will assume no liability for any problems that may occur inside or outside of the subcontracted limousine. 13. Though we provide access vouchers or add names to VIP lists for clubs, bars, and restaurants, admission is at the sole discretion of the facility and is subject to facility rules and regulations including but not limited to attire and schedule. It is the customer's responsibility to contact facilities directly for this information. Please note, you must inform your sales person 24 hours in advance of any clubs you would like passes to access or you will not receive any passes. You must write on your contract that you want passes for us to include them. Contract Obligations: I understand and agree to the length and usage along with any charges and further agree to pay for any and all damages my party may cause during the rental periods. I also agree to the Limousine Rules and Regulations. All damages are the sole discretion of the driver. I understand and agree to pay the entire contract price if cancellation policy is not followed. I understand the number of hours listed on this contract is the minimum hours I am agreeing to pay and that I am responsible for any overtime incurred. I understand that by signing this contract, I'm agreeing to all the rules and terms of the contract and authorizing FOUR SEASONS LIMO to charge my credit card for the agreed contract price. **Customers**
